## Call for Expression of Interest

The Bhutan For Life Fund Secretariat would like to invite Expression of Interests (EOI) from registered international/national consultancy firms for consultancy work on ***“Independent Evaluation of BFL Conservation Plan”***. The objective of this evaluation is to assess progress towards conservation Milestones and Activities during the first 2.5 years of the Program; identify any Program design problems; and draw lessons learned that can improve Program effectiveness, efficiency and sustainability of program benefits. Based on this assessment, it is expected that the evaluator will provide feasible recommendations regarding Milestones and Activities in the BFL Conservation Plan.

Consultant will be selected in accordance with the procurement procedures set out in the Bhutan for Life Fund Operating Manual using QCBS method.

- Firm’s experience
- Availability of key professionals with relevant knowledge mentioned in the draft ToR .
